

# ColorLok® Online Game Rules

## § 1 Online Game

The “ColorLok® Online Game” is an online game run by Mondi Paper Sales GmbH, Kelsenstrasse 7, 1032 Vienna, Austria (called “Mondi UFP” below). The objective of the game is to find a code to win. You can either search on each island or go directly to the entry form. To take part in the draw, entrants have to register at [www.mondigroup.com/colorlok](http://www.mondigroup.com/colorlok) and enter the code. The code can be found in addition in the mentioned possibilities under § 2 Entry conditions, point (4).

## § 2 Entry conditions

(1) This game is open to people aged 18 or over. Unless expressly excluded from taking part, minors require the permission of their parents or guardian in order to enter the competition. The competition is open to natural persons resident in the European Union, Norway, Switzerland, Croatia, Bosnia-Herzegovina, Serbia and Turkey.

(2) To take part in the draw, entrants complete the entry form, and activate the box “I agree to the Terms and Conditions“. Entrants are responsible for ensuring that their personal details, especially their email address, are correct. **The closing date for entries is 30.06.2013.** Electronic registration of the receipt of the e-card at Mondi UFP shall be used to determine whether entries have been sent in time.

(3) In order for a person to enter the game it is essential that all the personal details given are true and correct. Failure to comply with this condition may result in exclusion from the competition (see § 3 (3) below).

(4) Possibilities to get a code:

- There will be a stickering on the A4, 80 gsm reams on the products: IQ premium, IQ selection smooth, IQ appeal, MAESTRO® extra, MAESTRO®, supreme, MAESTRO® bulky, NAUTILUS® SuperWhite, NAUTILUS® ReFresh TRIOTEC, NAUTILUS® classic and BIO TOP 3® extra.

## § 3 Exclusion from the Game

(1) This game is not open to employees or agents of companies belonging to the Mondi Group.

(2) Mondi UFP reserves the right to exclude any person from this game in the event that he or she fails to comply with the rules here described.

(3) Any person who makes untrue statements regarding his or her person may be excluded from the competition.

## § 4 Implementation and Organisation

(1) The winners of the game will be selected by draw generated by an electronic random system. The draw to determine the winners of the 7 prizes will be carried out by Mondi UFP from 01.03.2013 until 30.06.2013 with no members of the general public present. The result of the draw of the winners is final. The right of entrants to verify the result of the prize draw is excluded. Winners will be notified by Mondi UFP in writing by email. Their names may be published on [www.mondigroup.com/colorlok](http://www.mondigroup.com/colorlok). Winners expressly agree to the publication of their names in this form. Winners who fail to respond within four weeks of transmission of this written email notification lose their right to their prize and a new winner will be drawn. Winners also lose their right to their prize if it is not possible to dispatch the prize to them within six months of the initial notification that they have won a prize for reasons attributable to the winners themselves. Mondi UFP is entitled to forward winners' personal details to the travel agency supplying the prize to enable dispatch of the prize to the winners.

(2) In total 7 prizes will be drawn:

a) 7 holidays for 2 persons:

- **Koh Samui:** Flight for 2 people to Koh Samui, 14 nights double room including breakfast
- **Tenerife:** Flight for 2 people to Tenerife, 7 nights double room including halfboard
- **Malta:** Flight for 2 people to Malta, 7 nights double room including halfboard
- **4 getaways in Austria:** hotel stay for 2 people, respectively 3 nights double room including breakfast

The winner has to contact the travel agency concerning the timing of his holiday.

(3) If the prize won is a trip, the relevant arrangements will be made directly and exclusively between the winner and the travel agency supplying the prize. A travel voucher with further information will be handed over to the winner. Confirmation of the winner's willingness and ability to make the trip won shall also be deemed a declaration of his or her willingness to accept the conditions of the tour operator. Unless expressly stated in the competition or unless expressly agreed otherwise, the winner shall bear the costs incurred by the winner during the trip (mini-bar, telephone etc.).

(4) In the event that acceptance of the prize is not possible for the winner for reasons for which are not attributable to the winner, the winner will receive a replacement prize equal in value to the prize won. The

winner shall receive a replacement prize equal in value to the prize won also in the event that the prize can no longer be delivered in the form originally published (change of model, seasonal goods etc.).

(5) Under no circumstances will prizes or replacement prizes be exchanged for cash equivalent.

(6) The right to the prize or replacement prize is not transferable.

(7) Complaints should be submitted in writing to Mondi UFP no later than fourteen (14) days after the cause for complaint has become known. The written complaint must state the name of the game and the reason for the complaint. No complaints will be accepted by telephone or after expiry of the deadline.

## **§ 5 Premature Termination of the Game**

Mondi UFP reserves the right to cancel the game or end it at any time without giving any reasons or prior notice. Mondi UFP will make use of this possibility especially if technical problems (such as viruses in the computer system, manipulation of or defects in the hardware and/or software) or legal issues make it impossible to guarantee that the game will be run as planned and published. In the event that such termination of the game is attributable to the actions of an entrant, Mondi UFP is entitled to demand compensation from this person for the losses incurred.

## **§ 6 Data Protection**

(1) In order to take part in the draw, entrants must register at [www.mondigroup.com/colorlok](http://www.mondigroup.com/colorlok) entering their names, email address and country, and activate the box "I agree to the Terms and Conditions". By entering the prize draw in the manner just described, winners expressly permit Mondi UFP to save the information necessary to run the competition for as long as the competition lasts and to forward this information to the travel agency supplying the prizes so that the prizes can be sent to the winners. Entrants can retract their agreement to the storage of their personal details at any time at [service.ufp@mondigroup.com](mailto:service.ufp@mondigroup.com) and thereby withdraw from the game. In addition under [www.mondigroup.com/colorlok](http://www.mondigroup.com/colorlok) is the possibility to register for a newsletter from Mondi, where you can unsubscribe at any time. The approval has no influence on the participation and chances to win.

(2) Mondi UFP undertakes to abide by the laws relating to data protection and to keep the secrecy of telecommunications. In this connection, please take special note of the information provided on data protection.

## **§ 7 Liability**

(1) Mondi UFP is released from all obligations as soon as the prize has been dispatched unless these provisions allow for earlier release from obligations.

(2) Mondi UFP accepts no liability for material or legal defects in the prizes supplied by the sponsors.

(3) Mondi UFP accepts no liability for the insolvency of a sponsor supplying the prize, nor for any consequences arising therefrom for the implementation and organisation of the competition.

(4) Mondi UFP accepts no liability for any loss or damage caused by Mondi UFP or one of its agents either wilfully or negligently or by violation of cardinal obligations. This does not apply to loss or damage caused by injury to life, the body and/or health.

The above-mentioned limitation of liability applies especially to loss or damage caused by errors, delays or interruptions in the transmission of data or similar, to faults in the technical systems or service, incorrect content, loss or deletion of data and viruses.

(5) If the prize is a trip, Mondi UFP further accepts no liability for consequences arising from a justified change to the itinerary of the trip or the justified cancellation of the trip by the tour operator.

The value of the trip cannot be exchanged for cash equivalent.

## **§ 8 Miscellaneous**

(1) The judges' decision is final; no correspondence will be entered into.

(2) The provisions and rules contained herein shall be governed solely by Austrian law.

(3) The court of jurisdiction is Vienna.

(4) In the event that any one of the provisions contained herein is invalid or becomes invalid, this shall not affect the validity of the other terms of use.

(5) These Competition Rules can be modified at any time by Mondi UFP without separate notice having been given. Such modified provisions can especially be published on the home page [mondigroup.com](http://mondigroup.com) or the relevant successor website.

(6) No purchase of any product sold by Mondi UFP or manufactured by a company belonging to the Mondi Group is necessary to take part in the prize draw, nor does any such purchase increase the entrants' chances of winning.
